Access & Special training for out of school children

4.1. Access

Universal access to schooling requires schooling facilities within reasonable reach of all children. Elementary schooling has big role to play in ensuring comparable opportunities to all children.

4.1.1. RTE norms for opening of new schools

Distance norms for opening of new schools / residential schools in case of remote habitations / transport facility – mention the relevant rules of state RTE Rules.

The following rules and norms are included in Right to Education – act 2009 rules with regard to Access. Rule 5(1) to 5(9) of the act discussed about access of schooling.

- In respect of children in classes I to V a school shall be established within a walking distance of one KM. of the neighborhood.
- In respect of children in classes VI to VIII a school shall be established within a walking distance of 3 KMs of the neighborhood.
- Wherever required, the state Government shall upgrade existing Primary School by adding VI to VIII classless and in case of Upper Primary schools by adding class VIII.
- Government can reduce the above rules, when there is difficult terrain, risk of landslides, floods, lack of roads and danger for young children to attend the school.
- Government shall provide transportation facility, residential facilities where ever establishment of neighborhood is not possible.
- Local Authority has to identify the neighborhood school(s), where children can be admitted.

State Government/Local Authority shall undertake school mapping every year.

4.1.2. Progress over view during 2016-17

Opening of new primary schools

New Primary Schools were not sanctioned during 2016-17.

Upgradation of primary schools into upper primary schools.

Primary Schools upgraded into Upper Primary School were not sanctioned during 2016-17.

Residential school for specific category of children.

There is no need of Residential Schools for specific category of children in the District and the schools have not proposed during 2016-17

Residential hostels

There is need of Two Residential Hostels for specific category of children in the District and the Hostels have not sanctioned during 2016-17

Transport facility

Transportation Facility to 2231 children of 166 Access Less Habitations proposed sanctioned during 2016-17 and the all the children not provided transportation facility to continue their Studies in the schools. because Transportation facility is not sanction for 2016-17.

4.1.4. Analysis on the status and gap

Primary Level:

Out of 2484 habitations, 2354 habitations are provided with regular primary schooling facility within 1 Km distance and still there is gap of 36 school less habitations in the District.

Upper Primary Level:-

Out of 2484 habitations, 2354 habitations are provided with regular upper primary schooling facility within 3 Km. It shows that still there are 130 school less habitations in the District and all these 130 habitations are not eligible to provide upper primary school as per neighborhood norms. not attending to any school and in other words these are all out of school children.

4.1.5. Issues and challenges in providing primary and upper primary schooling facility within the specified distance as per neighbourhood norms of State RTE Rules

Prakasam District is tribal populated district and these tribes live in small hamlets (Thandas) consisting of just 10-15 houses with population of 50 to 100 and 6-14 age group population of 5 to 15 children only. These tribes live in dense forests, where there is no proper transportation facility is available.

A sharp rise of tribal population in the District in the last decade seems to have given rise to an equally sharp demand for cultivable land & water sources. Pastures have shrunk considerably, some hills streams are no more and use of chemicals in new fields have poisoned grass and other flora. In search for livelihood opportunities these tribal people migrate from one place to another.

4.1.6. Strategies to provide access to all the schoolless habitations should be articulated under this item.

- ❖ Providing admission to school-less habitation children in existing residential schools and hostels particularly for the children living in small hamlets where seasonal migration is very high.
- ❖ Proposed to opening of 1st and 2nd classes in existing Ashram schools of Tribal Welfare Department.
- ❖ Proposed Opening of Primary sections in KGBVs.
- ❖ Providing transport facility to the children of school-less Remote habitations.

4.2 Special Training for OSC

Under this provision of RTE Act – 2009 it is responsibility of the Government to streamline all Out of School Children into formal schooling system by providing them Special Training which will prepare them for admission in the age appropriate class subsequently.

4.2.1 RTE Provisions

- 1 School management committee / Local authority shall identify Out of School Children right to receive special training such manner and with in such time limits, as may be prescribed.
- 2 The training shall be based on specially designed age appropriate learning material approved by the academic authority specified in section 29 (1) of RTE.
- 3 It shall be provided in classes held on the premises of the school or through classes organized in safe residential facilities.
- 4 It shall be provided by teachers working in the school or by teachers specially appointed for the purpose.
- 5 The duration shall be for a minimum period of 3 months which may be extended based on periodical assessment of learning progress for a maximum period not exceeding 2 years.

4.2.3. Analysis of status and gap

Above table reveals Out of 393796 children between age group 6-14. 384319 children attending school. 9474 children identified as Out of School Children. The gap is 0.975%.

4.2.4. Issues and challenges

- Reasons for not enrolment of OSC in regular schools
- A majority of Out of School Children in the District belong to disadvantaged communities, Schedule Tribes, Muslims, Migrants children with special needs, Urban Deprived Children, working children in other difficulties.
- Involving the children in seasonal works by the parents.
- Most of the children had enrolled in schools and later dropout, particularly in tribal mandals as some tribal communities have too many local festivals prolong religious ceremonies continued for weeks.

Above table reveals that 10 Mandals identified as mandals with highest no of out of schools children in the district. Out of 10 mandals 6 Mandals come under Tribal sub plan area, 1 mandal include urban area and 3-mandals include rural area.

4.2.5. Strategies for enrolment of out of school children

- Intensive propaganda and campaigns shall be organized in rural areas, particularly in remote tribal areas on RTE and importance of Education by involving members of Integrated Child Protection Scheme and Child Rights Protection Forum, NGOs working in the Mandal.
- Awareness campaigns in local languages on RTE involving Kalajatha Teams.
- Organizing special admission and enrollment drives during education fortnight in convergence with line departments.
- Organizing drives with Labour Department in Urban areas, where most of the children between 6-14 years are involved in Labour works in Hotels, Shops, Small firms and industries.
- Convergence meeting with line departments shall be convened to discuss the progress and gaps in Universal enrolment of the District. This would encourage a more open assessment of achievements.

Out of 9474 identified out of school children 6039 recent dropouts (below 4 months) of 6 to 9 years age group, 560 for HBE of CWSN children and 1248 osc for KGBV. Totally 7350 are proposed to enroll directly in the schools without providing special training.

There are 1890 out of school children in 48 Habitations which having 10 and above out of school children are proposed to provide non residential special training during 2017-18 for the period of (6,9, & 12) months

interest to go to school, in this way they came out of school children. The migrate mandals have huge out of school children found in the OSC survey. So we start seasonal hostels for a migration season from October to April months in this process we arrest the migrant dropout
